#### <u>Summary of Millbrook First Nation's</u> <u>Regular Chief and Council Meeting Held on April 13, 2021</u>

#### **Presentations to Council**

#### TE Wealth & TD Wealth

•Presentation on investment strategies for the Millbrook First Nation's 1919 Land Trust Account (i.e., how much money MFN could earn if the money is invested for a long period of time versus if MFN wants to spend the money on community projects immediately or in the short term).

•Chief and Council expressed their intent to engage the community on general ideas on how to spend the money before making any long-term investment decisions.

#### **Energy Efficiency NS**

- Presentation on the Community Building Energy Savings Program.
- Through Millbrook's energy assessments, \$20,000 a year of energy savings and/or opportunities were found where the investments will be paid back over 8-10 years.
- Millbrook had the most participation in the Community Building Energy Savings pilot in the entire province.

#### Council made the following resolutions to:

- Implement a robust new software system for financial and operations management brought forward by the CFO. The system can handle the budgeting and reporting requirements of the funds, departments, and programs managed by the organization.
- Accept Millbrook Finance Department's proposal to develop a comprehensive financial policy and procedures manual with the assistance of MNP.
- Join all NS First Nations in seeking a Declaration from the courts stating that DFO's management of the fisheries is an infringement on Mi'kmaw rights.
- Increase the maximum per household Housing Repairs Grant from \$500 to \$750 and for seniors from \$750 to \$1000.
- Pursue the purchase of two private properties in Beaver Dam adjacent to Millbrook's reserve to be added to the Beaver Dam reserve if the acquisition of the properties is successful.
- Provide a donation of \$5000 to the Immaculate Conception Church towards the enhancement of art features and a new statue of Mary.
- Initiate the planning process for building houses in Beaver Dam and Sheet Harbour by reviewing and re-visiting the existing infrastructure plan.
- Provide a donation of \$5000 in support of the search efforts for fishing captain Jumbo Sock and vessel Tyhawk.

Millbrook First Nation Chief and Council also reviewed and discussed several letters of request from community members. Those items were delegated to staff for appropriate action.

#### Medical Services at the Health Centre

Millbrook band and community members can access medical services at the community Health Centre by calling to book an appointment with the physician or asking to be assessed by the nurse.

At the Health Centre, patients are triaged according to how sick they are, risks of worsening, and care needs based on their presenting signs and symptoms using a triage system (<u>https://ctas-phctas.ca/</u>) to prioritize patient care.

Therefore, upon calling for assessment or arriving at the Health Centre for an unscheduled appointment, each patient will be asked questions relating to the nature of their visit and a nurse may then do a physical assessment including vital signs.

Based upon the triage nursing assessment, each patient's needs will be cared for in an appropriate manner. The nurse may discharge the patient with instructions including medication, ask the patient to book a follow up appointment, or consult the physician on call.

#### Attention: New Millbrook First Nation Members Under 19 Years of Age

For Millbrook First Nation members under the age of 19 years, the Millbrook Enterprise Credits are placed in a trust fund. When Millbrook members reach the age of 19, they must apply to Millbrook First Nation to have their Millbrook Enterprise Credit money released from the trust. Millbrook Chief and Council is working on a plan to define a Moderate Livelihood for our community and to eventually establish a "Moderate Livelihood Fisheries Management Plan." Based on band member guidance and a community ratification process, Chief and Council will develop and implement a community-based regime to address interim and long-term Moderate Livelihood access and management solutions.

Millbrook and the Mi'kmaw Conservation Group (MCG) have worked together to develop a Moderate Livelihood Questionnaire that will help in the development of a Moderate Livelihood Management Plan. The survey is intended to gather perspectives and assess the community's needs for the writing of a management plan.



# **Environmental Assessment Process**

The process for building a mine is in-depth and very thorough. You may have heard about our future mine projects - we want you to know the work that goes on "behind the scenes" to ensure that all our projects are environmentally sound and responsible. Below, you'll find all the steps of the Environmental Assessment Process.

- **Project Description** Develop a description of the proposed project and submit to the Impact Assessment Agency of Canada (IAAC)
- **2 Baseline Information & Engagement** Adjust Project Description based on additional technical information and Indigenous and community engagement.
- **3 Validate Information** Ensure that the information provided has been fully validated by those affected by the Project including Indigenous communities and other stakeholders.
- 4 Complete and Submit Environmental Impact Statement (EIS) Complete and submit the EIS to IAAC
- **5 Engagement** Update EIS based on engagement and validation
- 6 Approvals & Follow-up

Engagement is a part of all of our future plans and will continue to happen through the life of our projects.

The **Beaver Dam Project** is at Step 5 in the process. Through Millbrook's Community Engagement Officer, Atlantic Gold is engaging with Millbrook local land users to understand and document the community members' views on the EIS conclusions as well as on the proposed mitigation and monitoring measures. Atlantic Gold will take those views into consideration when revising and resubmitting the EIS and during all phases of the future proposed mine. We would like to involve interested local community members directly in our environmental programs if possible.

**Atlantic Gold** 

The **Fifteen Mile Stream Project** is at Step 4 in the process. The EIS has been submitted and is being reviewed by Indigenous communities and groups including Millbrook First Nation. Atlantic Gold is looking forward to working with Millbrook and other Mi'kmaq communities and groups to help fill information and knowledge gaps, especially in relation to current and future Mi'kmaq land use for the area.

#### TOWN OF TRURO DEER MANAGEMENT WORKING GROUP URGES RESIDENTS NOT TO FEED THE DEER

The Truro Deer Management Working Group continues their work to build a Deer Management Strategy for the Town of Truro. Part of the overall strategy includes working towards changing human behaviours and attitudes, as long-term success in reducing the urban deer population will be heavily dependent on changing the human/deer interactions that currently exist.

As part of this, the Working Group is urging residents not to feed the deer population in Truro. Late spring and early summer is when fawns are born and this represents the season with the highest deer population. While many factors affect deer reproduction, one major factor is the availability of food in an area. Therefore, it's crucially important for deer management that all residents do their part to help to control the deer population.

Over the next few months, the Town of Truro will be highlighting the importance of not feeding the deer, and also promoting deer deterrent gardening options and techniques for residents to consider.

Changing human/deer interactions in the Town of Truro is one major component to controlling the urban deer population. If effective, it could help to reduce the need for more invasive control measures.

All Millbrook Band Members are entitled to apply for the Millbrook Housing Repair Grant.

For every housing unit (except private rentals) occupied by Applicant, a reimbursement of up to **\$750.00** will be made to the homeowner for repairs once this year. For every Senior homeowner **\$1000.00**. This applies only if you do not qualify or do not receive Social Assistance.

Application date for this housing initiative begins April 1, 2021. Receipts dated before April 1, 2021 will not be accepted. This application expires March 31, 2022.

<u>Original receipts</u> are necessary and must be dated within that year, <u>with applicant's name (IMPRINTED ON RECEIPT/INVOICE</u> FROM SUPPLIER), excluding labour.

Housing units that are private rentals are not eligible for repairs.

Allowable Housing Repairs:

- Roof Material.
- Exterior doors and windows including storm/screen doors.
- Heating systems including boilers (hot water or steam), forced air furnaces, chimneys, and related components.
- Domestic hot water tanks, septic tanks, and tile beds.
- All household Appliances.
- Toilets, tubs, sinks, and faucets.
- Smoke detectors, light fixtures, ceiling fans.
- Construction materials, paving, and gravel.

Housing Unit must be in the name or owned by Applicant.
